NOTE: Members will be responsible for cleaning their own pens. Each exhibitor must clean (completely strip) their pen between Tuesday and Saturday following the Junior Fair exhibit at the Canfield Fair. If the exhibitor is not able to clean his/her own pen, then arrangements should be made within your club and/or another exhibitor to make sure your pen is cleaned. Manure should be taken to the manure pit. Manure pits should only contain manure, straw & sawdust. Garbage (paper, pop cans, plastic, etc.) should be disposed of in garbage cans. Bedding, food, and water must remain in the pen until Tuesday morning for any market animal. Non-market may be removed Monday night. **If a member does not clean their pen, they may not be permitted to exhibit the following year. Exhibitors not cleaning/stripping their pen between the Tuesday following the Junior Fair Show and Saturday during the Post Fair Clean-up, will be notified of their negligence and fined a \$20.00 per pen cleaning fee, which will be donated to the Mahoning County Poultry Club. If a non-market member does not clean their pen, he/she will be asked to pay the committee before they may enroll the following year. Members will be notified by the Small Animal Committee and must pay prior to enrollment for the next year.** Exhibitors are encouraged to attend the post fair clean-up on Saturday after the fair at 9:00 a.m.
